II. Purpose of Addendum

The facility requested that the license be increased from 70 beds to 76 beds.

III. Methodology

The Department of Community Health, Bureau of Health Systems, Health Facilities Engineering Section, conducted an on-site inspection of the Manoogian Manor home on 6/30/2008.

IV. Description of Findings and Conclusions

The additional six beds were approved by H.F.E.S. on 6/30/08, given the available floor space in the home. The total day/dining area square footage requirement for 76 beds is 2280 square feet. The total day/dining area in this home was measured to be 2667 square feet. Six single bedrooms will be changed to double bedrooms. There was no other change in the floor plan of this home.

V. Recommendation

It is recommended the home for the aged license of Manoogian Manor be increased to 76 beds.
