II. Purpose of Addendum

The Licensee has requested an increase in capacity within the same licensed category of AFC large group home. The home was originally licensed for 14 residents and will now be licensed to provide care for 20 residents. No other changes to this license will be made at this time.

III. Methodology

January 29, 2010 – Licensee submitted a letter requesting that the capacity of the facility be increased from 14 residents to 20 residents.

February 4, 2010 – An on-site inspection was completed. The Licensee was found to be in compliance for all licensing rules.

IV. Description of Findings and Conclusions

The facility is currently licensed for fourteen (14) residents. At the time of the original licensure, the licensee had not yet completed the remodeling of three bedroom units and thus those units were not included in the original licensed capacity. The licensee has now finished the remodel of the three remaining units. The bedroom units were measured during the on-site inspection and have the following dimensions.

Bedroom #	Room Dimensions	Total Square Footage	Total Resident Beds
Unit 1	28'X26'	728	2
Unit 4	27'X27'	729	2
Unit 6	28'X28'	784	2

The living, dining, and sitting room areas measure a total of 1935 square feet of living space. This exceeds the minimum of 35 square feet per resident requirement.

Based on the above information, it is concluded that this facility can accommodate twenty (20) residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

A fire safety inspection was completed by the Bureau of Fire Safety and found the facility to be in full compliance with applicable fire safety rules.

V. Recommendation

It is recommended that the Licensed capacity of this facility be increased to twenty (20) residents.
