On-site inspection conducted on 07/09/2010.


**IV. Description of Findings and Conclusions**

Each resident room measured as follows:  
Room #11- 12'6" x 11' = 137.5 square feet  
Room #15- 12'6" x 11' = 137.5 square feet  
Room #17- 12'6" x 11' = 137.5 square feet

Each room has ample space for two residents and each room has the necessary furnishings for each resident.

**V. Recommendation**

I recommend that the change of use space is approved for Resident Rooms #11, #15, and #17 to be used as semi-private rather than private rooms.
