II. Purpose of Addendum

Licensee requested an increase in capacity after furnishing another bedroom for resident use.

IV. Description of Findings and Conclusions

Licensee decided to license another bedroom for resident use. This bedroom was initially licensed for resident use, but later changed to be used by the licensee's family.

The bedroom contains over 233 square feet, which will provide the required amount of space for 3 residents in this bedroom. The bedroom has a half bath that will be available to the residents in that bedroom. The home has adequate living space to accommodate the increase in capacity.

The home now contains 3 bedrooms approved for resident use; the new bedroom on the north of the house will have 3 beds, the southwest corner bedroom is approved for 2 residents and the southeast corner bedroom is approved for 1 resident.

V. Recommendation

It is recommended that the licensed capacity for this adult foster care family home be increased from 4 to 6 residents effective 12/23/09.
