II. Purpose of Addendum

The purpose of this addendum is to describe a change in room function and the development of an Alzheimer's program. The west wing of the first floor is now a secured memory unit. This resulted in the lowering of licensed bed capacity to 101.

III. Methodology

On May 12, 2010, the authorized representative submitted an Alzheimer's program statement and a revised facility floor plan of this unit for review. On November 16, 2010, the Bureau of Fire Services provided an acceptable fire safety certification. On November 23, 2010, Health Facilities Engineering Section occupancy approval was granted for the memory unit.

IV. Description of Findings and Conclusions

This secured memory unit has 13 single occupancy and one double occupancy resident rooms. Single occupancy rooms are 10' X 14' while the double occupancy room is 12' X 14'. Each resident room is comprised of a toilet room with a sink, combined living/sleeping area, closet, and a window. The unit has one resident shower room for the 15 licensed beds. The shower room also contains a toilet and sink. A large 17' X 38' common resident space is divided into three areas containing couches and a television, a kitchenette and dining area, and an open recreational space. This common resident space is lined with windows and allows viewing of a secured enclosed courtyard. The unit contains a secured laundry closet containing a washer and dryer and a janitor's closet for staff use only. A clean linen closet is easily accessible to residents, staff, or guests and is located on the hallway.

The secured memory unit residents have access to a fenced exterior area where with staff supervision they may participate in outside activities safely. The layout within the secured unit provides an area for residents to relax, socialize, and participate in activities in a home-like atmosphere. All exit doors within the unit, as well as the doors to the unsecured area of the home, are equipped with magnetic locks that require entry of a code to open. This is to prevent residents from wandering away unsupervised. Additionally, activation of exit doors without code entry or activation of emergency pull cords within resident rooms is communicated to handheld radios that are carried by all staff. The radio summons staff to the exit or room requiring immediate assistance. The unit shower room, janitor closet, and laundry closet are all key entry for resident safety.

I reviewed the home's proposed secured memory unit Alzheimer's program statement. It is compliant with the requirements of MCL 333.20178.

This revised floor plan and change in room function do not constitute a major building modification.

V. Recommendation

I recommend that the home's licensed bed capacity be lowered to 101 and a program for Alzheimer's disease and related conditions be approved.
