II. Purpose of Addendum

On 10/13/2010, Lisa Flower submitted a written request to increase the capacity of her license from 13 residents to 15 residents once an addition of four bedrooms to the facility was completed.

III. Methodology

01/31/2011, an on-site inspection of the facility was completed.

IV. Description of Findings and Conclusions

At the time of the modification request, the facility had ten bedrooms and was licensed for 13 residents. An addition, which consisted of four private bedrooms, an extension of the hallway, an additional exit door, and a wheelchair ramp was completed on 01/26/2011. The Bureau of Fire Safety issued occupancy approval on 01/28/2011. I completed an on-site inspection of the addition on 01/31/2011. Each of the four private bedrooms measured 11'2" x 13'0" providing a total square footage of 145.21 feet for each room. All four bedrooms were provided with the required furnishings. There is also ample living and dining space in the facility to accommodate two additional residents.

The number of staff members is scheduled to increase to meet the needs of the additional residents in the home. An additional person has been added to the nighttime shift, to the time between breakfast and lunch, and to the time between dinner preparation and bedtime.

V. Recommendation

I recommend that the capacity of the license increase from 13 to 15 residents.
