II. Purpose of Addendum

The purpose of this Addendum to the Original Licensing Study is to change the use of bedroom space without changing capacity.

III. Methodology

On March 7, 2011, I received and reviewed a Request For Modification Of The Terms Of The License.

On March 7, 2011 I inspected and measured the proposed conversion of the northeast provider bedroom to a private resident bedroom. I also inspected and measured the proposed conversion of the southwest semi-private resident bedroom to a private resident bedroom.

On March 7, 2011, I received and reviewed Fire Alarm and Sprinkler Inspection Reports.

On March 7, 2011, I received and reviewed revised Emergency Evacuation and Floor Plans.

IV. Description of Findings and Conclusions

A signed and dated Request For Modification Of The Terms Of The License was reviewed. This document requested changing the use of space in the northeast provider bedroom to a private resident bedroom. This document also requested changing the use of space in the southwest semi-private bedroom to a private bedroom. This document further indicated the provider bedroom would relocate to the walk-out basement with prior zoning approval.

The northeast bedroom measured 21' x 21' or 441 square feet of bedroom space. The southwest bedroom measured 21' 9" x 14' or 304.5 square feet of bedroom space. Each bedroom has an operable window. Each bedroom was furnished with a bed, dresser, chair, walk in closet, and mirror. The bedrooms were equipped with non-locking-against-egress door hardware with private access.

Thumb Alarm Systems conducted a fire alarm inspection on August 24, 2010, and determined the system in good working order. Beck Fire Protection, Inc. inspected the sprinkler system on October 21, 2010, and determined the system in proper working condition.

I reviewed the revised Emergency Evacuation Plan. This plan illustrated the evacuation route from the northeast bedroom and all other existing resident bedrooms.

I reviewed the revised Floor Plan. This plan illustrated the northeast provider bedroom as a private bedroom and the southwest semi-private bedroom as a private bedroom.

V. Recommendation

I recommend a change in the use of northeast provider bedroom to a private resident bedroom. I also recommend a change in the use of the southwest semi-private bedroom to a private bedroom. The home capacity of 20 residents has not changed and the total capacity shall not exceed this number at any time.
