II. Purpose of Addendum

The licensees' requested to have a first floor bedroom approved for resident use and discontinue the use of the second floor bedroom for residents. They do not want to change their capacity, just the bedrooms that are approved for residents.

IV. Description of Findings and Conclusions

The first floor bedroom is 11'9" x 11'3" resulting in 132 square feet of usable floor space. The bedroom was appropriately furnished. It is located next to the existing 2 person bedroom and adjacent to the bathroom.

The second floor bedroom has been designated on the floor plan as a guest bedroom.

V. Recommendation

It is recommended that the first floor bedroom be approved for resident use and the second floor bedroom no longer be designated as an approved resident bedroom effective 03/14/11. The licensed capacity remains at 3.
