**IV. Description of Findings and Conclusions**

Licensees reported they have switched bedrooms. They will be using the middle bedroom as their bedroom and want to have the larger bedroom in the northeast corner approved for resident use. Both bedrooms are located on the second floor.

The northeast bedroom has 134 square feet of usable floor space after deducting space for the wardrobe. Two twin beds were in place and ready for resident use. The home has a large living room and dining room area that provides adequate living space for all occupants of the home. Measurements are on file.

The approved resident bedrooms for this home include a 2 person bedroom on the main floor and 2 – 2 person bedrooms on the second floor. The middle bedroom on the second floor is the licensees' bedroom.

**V. Recommendation**

It is recommended that the capacity of Lydia's Foster Home be increased from 5 to 6 effective 08/25/11.
