**II. Purpose of Addendum**

The licensee submitted a written modification request for change of use – space. The licensee added two bedrooms and 1 full and ½ bath room. The capacity does not change.

**III. Methodology**

09/09/2011 – I inspected the facility and measured the bedrooms and inspected the new bathrooms to insure compliance with the rules for an adult foster care family home license.

**IV. Description of Findings and Conclusions**

The first additional bedroom measured 12' x 14 'or 168 square feet for 1 resident. The second additional bedroom measured a total of 24' x 24' or 288 square feet for 2 residents. The additional ½ bathroom is off of the second bedroom. The new full bathroom has a tub with a side door for easy access. One of the existing bedrooms will now be utilized for 1 resident.

**V. Recommendation**

I recommend that the licensee utilize the two additional bedrooms as proposed as well as the new full and half bath rooms.
