## **IV. Description of Findings and Conclusions**

Bedroom #3 measures 140 square feet and has ample space to house two residents. Bedroom #3 was arranged with the required storage space for each resident's belongings and there was more than three feet of space between each resident bed. The living space is more than adequate for 15 residents and the staff pattern also accommodates 15 residents with minimal needs.

## **V. Recommendation**

Based on the inspection on 11/07/2011, I recommend that the capacity of the license is increased from 14 to 15 residents.
