Bedroom # 2	14 x 9.5	131 sq. ft.	2
Bedroom #3	16 x 9.5 (9 x 3.5)	180 sq. ft.	2

The home has 469 square feet of indoor living space which is more than enough for 6 residents.

I recommend that the capacity be increased from 5 residents to 6 residents.
