IV. Description of Findings and Conclusions

The basement bedroom has 152 square feet of usable space. It has a large egress window within the room and the basement level has a door that exits at ground level through the garage, as well as the exit via the upper level of the home. This bedroom has access to its own living room and full bathroom facility in the basement level.

The licensees are not requesting to increase the capacity of their adult foster care family home. Their stated intent is to provide each of their 3 residents with a private bedroom.

V. Recommendation

It is recommended that the basement level bedroom be approved for resident use effective 12/13/11. As noted, the capacity of the adult foster care family home is unchanged at 3.
