Licensee remodeled and turned existing 4 bedroom space into 2 2-person bedrooms

**III. Methodology**

01/03/12 – Contact telephone call received  
Licensee made verbal request to modify her existing bedroom space

01/05/12 – Inspection completed on-site  
Licensee submitted written modification request

01/06/12 – Revised floor plan showing modification received

**IV. Description of Findings and Conclusions**

Licensee had a large 4-person bedroom for residents at the end of the north hallway that was approved for resident use at the time the original license was issued, 09/15/94. Licensee remodeled and put in a wall to divide the space into 2 separate bedrooms. Each room has its own entryway and 2 windows. Bedroom # 1 has 135 square feet of floor space and Bedroom # 2 has 133 square feet. The furnishings remain the same as when it was a 4-person room. No changes were made to Bedroom #3. The licensed capacity of the home remains at 5.

**V. Recommendation**

The use of the new 2 2-person bedrooms for resident use is approved effective 01/06/12. The licensed capacity of the home remains 5.
