II. Purpose of Addendum

The purpose of this addendum is to describe ownership interest of the licensee and document the licensee's correct name.

III. Methodology

On 10/19/11, I received and reviewed an updated application from Leisure Living Management of Grant Inc. to operate the home for the aged known as Fountain View Retirement Village of Grant. On 3/27/12, I completed a business entity search at the Department of Licensing and Regulatory Affairs website.

IV. Description of Findings and Conclusions

A review of the licensing file revealed the original home for the aged license was issued 10/1/99 to Leisure Living, Inc.

A review of the Department of Licensing and Regulatory Affairs' Business Entity Search revealed that Leisure Living, Inc. was dissolved 5/15/83. Further review revealed a valid registration of Leisure Living Management of Grant, Inc. since 8/10/92.

Review of the 10/19/11 updated home for the aged application submitted by the licensee revealed the licensee's name as Leisure Living Management of Grant, Inc. The federal employer tax identification number on the application is the same as that of Leisure Living, Inc. listed in the licensing file.

Baruch SLS Inc. is the corporate parent company of Leisure Living Management of Grant, Inc. Leisure Living Management of Grant, Inc. remains legally responsible for the home for the aged care provided at Fountain View Retirement Village Grant.

The building and grounds of the home for the aged are owned by Leisure Living Management of Grant, Inc.

The administrator and authorized representative have been appointed by Leisure Living Management of Grant, Inc.
