### II. Purpose of Addendum

An application from Briarwood Assisted Living was received in this office on 6/29/11 requesting an increase in bed capacity from 38 to 55.

#### III. Methodology

This project involved the construction of an addition to the current home for the aged. This new addition will house 15 newly licensed home for the aged beds and includes two new distinct living spaces. One of the areas increases capacity in the general population of the home and contains eight bedrooms, ample day/dining space and an activity room. The second area contains a new secured memory care unit. This unit has seven bedrooms, a separate nursing station, a kitchen and generous day/dining space.

An on-site inspection of the addition was completed on 7/12/12. The revised program statement for the home was also reviewed. The new addition was found to be in compliance with all homes for the aged licensing rules.

### IV. Description of Findings and Conclusions

The Department of Licensing and Regulatory Affairs, Bureau of Fire Services granted final approval of this project on 5/23/12.

The Department of Licensing and Regulatory Affairs, Health Facilities Engineering Section granted approval of the license increase on 6/26/12.

### V. Recommendation

I recommend an increase of the licensed capacity of the Briarwood Assisted Living home for the aged from 38 to 55.
