II. Purpose of Addendum

The licensee, Mary Pepera, requested that the capacity of her facility be increased from three AFC residents to five.

III. Methodology

On 10/09/2012, I inspected the facility and interviewed the licensee.

IV. Description of Findings and Conclusions

The licensee would like to use a previously unused upstairs bedroom (Room # 3) for resident occupancy.

Resident bedrooms were measured during the on-site inspection and have the following dimensions:


Bedroom #	Room Dimensions	Total Square Footage	Total Resident Beds
1	12'3" x 9'6"	116.37	1
2	15'3" x 8'9"	133.43	2
3	16'6" x 9'5"	155.43	2

The living and dining areas measure a total of 345.98 square feet of living space. This complies with the minimum requirement of 35 square feet for the 7 "occupants".

Based on the above information, it is concluded that this facility can accommodate **five (5)** AFC residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

It is recommended that the capacity of the facility be increased to five AFC residents.
