II. Purpose of Addendum

The corporation's name changed from Waltonwood at Lakeside, LLC to Waltonwood at Lakeside I, LLC on 12/22/09, so the licensee's name needs to be changed.

IV. Description of Findings and Conclusions

Area Manager Betsy Montgomery stated that the licensee's name should be changed from Waltonwood at Lakeside LLC to Waltonwood at Lakeside I, LLC because the license was issued to an incorrect name of the business entity. Ms. Montgomery stated that the Corporation Division's Business Entity Search on the Department of Licensing and Regulatory Affairs' website included that the corporation's name was changed via Amended Articles of Incorporation, so she changed the licensee's name on BCAL's Bureau Information Tracking System on 9/6/12. This was not a change of ownership but was a correction of the licensee's name.

Pulvinder Grewal of Singh Development LLC stated that the Employer Identification Number for Waltonwood at Lakeside LLC was the same Employer Identification Number for Waltonwood at Lakeside I LLC, so this was not a change of ownership.

The Homes for the Aged Application for Licensure in the BCAL file was signed and dated on 7/12/07 and identified the Owner/Company as Waltonwood at Lakeside, LLC with Federal I.D. Number 20-2958268.

A Corporation Division's Business Entity Search revealed that Waltonwood at Lakeside, LLC and Waltonwood at Lakeside I, LLC had the same ID Number B5311W and the entity's name was changed from Waltonwood at Lakeside, LLC to Waltonwood at Lakeside I, LLC on 12/22/09 when a Certificate of Amendment to the Articles of Organization was filed.

V. Recommendation

The licensee's name was properly changed from Waltonwood at Lakeside, LLC to Waltonwood at Lakeside I, LLC.
