The new owner of the property is Crystal Creek Property LLC. Michael Stein is the only member of this limited liability company. The property was purchased on 12-31-2012.

Crystal Creek Investors, LLC allocated the capital to purchase the property. Members of Crystal Creek Investors LLC are Sweetsucker Ltd., Michael Stein and Canton Syndication.

Michael Stein designed in writing Louise Roney as the person who shall be on-site or immediately available and who shall have the authority to carry out the licensee’s or administrator’s responsibilities in the absence of the licensee or administrator.

These changes do not affect the licensee’s compliance with PA 218 and the licensing rules.

**V. Recommendation**

I recommend the status of the license remains unchanged.
