III. Methodology

On June 25, 2013, I reviewed a request for modification of terms of the license.

On July 2, 2013, I completed an onsite inspection of the facility.

IV. Description of Findings and Conclusions

On June 25, 2013, the licensee submitted a written request to increase the capacity of the home from 5 to 6 residents. The licensee changed the occupancy of the upstairs resident bedrooms to include three dual occupancy bedrooms. Previously the licensee had two approved bedrooms being used for residents, one with three (3) residents and the other with two (2). Use of the third upstairs bedroom would allow an increase of capacity from 5 to 6.

On July 2, 2013, I inspected the facility. The third resident bedroom was measured and met the criteria for a resident bedroom. The bedroom was approved for use as a resident bedroom.



The home was originally licensed for 5 residents at the time of the original licensure on October 25, 2004.

The home is currently equipped to be suitable for 6 residents.

It is recommended that this facility increase in capacity from 5 to 6 residents.


