IV. Description of Findings and Conclusions

I completed an onsite inspection on September 23, 2013. The licensee stated she would like to increase capacity to 5 and will notify Northeast Michigan Community Mental Health that she can take another resident once the addendum is completed.

Resident Bedroom 3 measures 9'5" X 8'7" and 5'8" X 4'9" for a total of 107 square feet. Bedroom 3's total capacity is 1 resident.

V. Recommendation

I recommend this adult foster care family home license be increased to a capacity of five (5).
