II. Purpose of Addendum

The purpose of this addendum is to document the licensee's request to increase the capacity of the facility from 11 to 12 residents.

III. Methodology

On April 15, 2014 the licensee submitted a *Request for Modification of the Terms of the license* to me. The request was for a change of capacity to 12 instead of 11 residents.

IV. Description of Findings and Conclusions

On February 18, 2014 I contacted State of Michigan Fire Marshal Brent Connell. He indicated that as long as it is an existing home and the licensee is not changing the license, the upstairs bedroom can be licensed and does not have to be sprinkled.

On May 13, 2014 I conducted an onsite inspection and measured the upstairs bedroom. The bedroom measured 82.41 square feet, adequate room for one resident.

V. Recommendation

I recommend that the capacity of this home be increased to 12 residents.
