
III. DESCRIPTION OF FINDINGS & CONCLUSIONS

On April 30, 2014, a settlement agreement was signed agreeing to the uncontested revocation of license # AS190010559 for the Airport Road Home, a small group adult foster care facility with special certification. To avoid relocation of residents, a few of whom had lived in the facility since its opening in 1987, an emergency license as authorized by Public Act 218, section 22, subsection 6, is being issued. Airport Road Home is owned by Clinton, Eaton, and Ingham Community Mental Health (CEI-CMH), and license # AS190010559 was revoked and its CMH contract terminated. .

In conjunction with Pat Miller of CEI-CMH, a qualified applicant, Valley Residential Serv Inc agreed to provide services to the residents during the 90-day emergency licensing period. Valley Residential Serv Inc is an existing licensee whose facilities are in compliance with applicable regulations as of April 29, 2014, according to BITS. An application was submitted to BCAL on April 29, 2014, and I have determined by an on-site inspection of the facility on April 25, 2014, that the facility is in substantial compliance with the physical plant requirements. I have received documentation confirming that the mental health contract with Bay Human Services has been terminated and that a temporary contract with Valley Residential Serv Inc has been established and the contract is dated April 30, 2014. Consequently, Valley Residential Serv Inc will provide services to the residents at Airport Road Home under an emergency license effective April 30, 2014. This will include special certification services.

IV. RECOMMENDATION

I recommend issuance of a 90 day emergency license to this adult foster care small group facility with a capacity of six (6).
