On 08/13/2014, Lisa Cabada submitted a death certificate from the State of Michigan, Department of Community Health, stating that Joann M. Fisher died on 06/30/2014.

IV. Description of Findings and Conclusions

The Bureau of Children and Adult Licensing policy states that upon submission of a valid death certificate the licensee name is to be removed from the adult foster care license.

V. Recommendation

I recommend the license for Fishers AFC (AF620344469) should be amended to include the name of Lisa Cabada as the sole licensee for this facility.
