II. Purpose of Addendum

Licensee is increasing resident capacity from 2 to 3. Facility has adequate space in Bedroom 1 to accommodate the capacity increase..

III. Methodology

07/01/2014 – Licensee requested increase in capacity during a renewal inspection.

07/01/2014 – Inspection completed. Full compliance.

IV. Description of Findings and Conclusions

Parrish Adult Foster Care was originally licensed on 08/30/1999 for a capacity of 4 residents. The capacity was then changed from 4 to 3 on 08/21/2001. The capacity was again changed from 3 to 2 on 04/13/2006. The facility is a single story structure with all bedrooms and other living areas located on the main floor.

Bedroom 1 contain in excess of the required 130 square feet of usable floor space per bed. Bedroom 1 has furnishings that meet the licensing requirements. There is a living room and a dining room giving the residents adequate living space.
