**II. Purpose of Addendum**

Effective June 15, 2015, licensee Brookdale Place of Ann Arbor LLC is changing the name of the home for the aged facility Brookdale Place of Ann Arbor to become Brookdale Ann Arbor.

**III. Methodology**

Authorized representative Beth Mell submitted a letter via email on June 19, 2015 to the Bureau of Children and Adult Licensing informing the department that the name of the facility has been changed from Brookdale Place of Ann Arbor to Brookdale Ann Arbor effective June 15, 2015. Ms. Mell explained this change is the result of a simple rebranding project. There has been no change in ownership, operations, location, etc.


**IV. Description of Findings and Conclusions**

According to the Michigan Department of Licensing and Regulatory Affairs corporation division business entity search licensee Brookdale Place of Ann Arbor LLC is a Foreign Limited Liability Company on active status since formation/qualification on 10/14/2009. It has assumed names of Brookdale Place of Ann Arbor (11/02/2009) and Brookdale Ann Arbor (05/22/2015).

The facility's authorized representative has submitted a request to change the name of the facility from Brookdale Place of Ann Arbor to Brookdale of Ann Arbor.

**V. Recommendation**

It is recommended that the name of the home for the aged facility license #AH810305217, located at 2190 Ann Arbor-Saline Road, Ann Arbor, MI 48103, be changed from Brookdale Place of Ann Arbor to Brookdale Ann Arbor, as requested.


