II. Purpose of Addendum

Effective June 15, 2015, licensee Brookdale Senior Living Communities, Inc. is changing the name of the home for the aged facility from Wynwood of Meridian, a Brookdale Community to Brookdale Meridian AL.

III. Methodology

Authorized representative Beth Mell submitted a letter via email on June 19, 2015 to the Bureau of Children and Adult Licensing informing the department that the name of the facility has been changed from Wynwood of Meridian, a Brookdale Community to Brookdale Meridian AL effective June 15, 2015. Ms. Mell explained this change is a result of a simple rebranding project. There has been no change in ownership, operations, location, etc.


IV. Description of Findings and Conclusions

According to the Michigan Department of Licensing and Regulatory Affairs corporation division business entity search, licensee Brookdale Senior Living Communities, Inc. is a Foreign Profit Corporation on active status since incorporation/qualification on 06/15/1994. It has approximately 64 assumed names including Wynwood of Meridian and Brookdale Meridian AL (MI).

The facility’s authorized representative submitted a request to change the name of the facility from Wynwood of Meridian, a Brookdale Community to Brookdale Meridian AL.

V. Recommendation

It is recommended that the name of the home for the aged Wynwood of Meridian, a Brookdale Community be changed to Brookdale Meridian AL, as requested.
