II. Purpose of Addendum

The licensee requested to use the lower level of the facility for residents.

III. Methodology

On 10/21/2015, Licensing Consultant Grant Sutton and I conducted an on-site inspection of DeepWoods AFC Home.

IV. Description of Findings and Conclusions

The lower level of the facility consists of two sitting areas, a full bathroom, three bedrooms and another room that may be used as a live-in bedroom. There are two approved means of egress from the lower level.

The furnace and hot water heater are located on the lower level of the facility in a room that is constructed of materials that provide a 1-hour-fire-resistance rating with a 1-3/4 inch solid core door in a fully stopped frame, equipped with an automatic self-closing device and positive-latching hardware. The facility is equipped with interconnected, hardwire smoke detection system, with battery back-up, which was installed by a licensed electrician and is fully operational.

The bedrooms on the lower level were measured during an on-site inspection and have the following dimensions:



One of the sitting areas on the lower level measured a total of 211.40 sq. ft. The two sitting areas on the lower level combined with the sitting and dining areas on the main floor of this facility exceed the 35 sq. ft. per person requirement.

Based on the above information as well as the information documented in the original licensing study report, it is concluded that this facility can accommodate **six (6)** residents. It is the licensee's responsibility not to exceed the facility's licensed capacity.

V. Recommendation

I recommend that the lower level of the facility be used for residents.
