6/15/15 Received an email message from licensing’s central office that the facility’s name was changed to Brookdale Northville and Beth Mell will submit a written request for a name change on the license.


6/19/15 Received a letter from Ms. Mell.

Beth Mell’s 6/19/15 letter requested a facility name change from Wynwood of Northville, a Brookdale Community to Brookdale Northville; included that the name change occurred on 6/15/15; and “This change is the result of a simple rebranding project; there has been no change in ownership, operations, location, etc.”
