II. Purpose of Addendum

Increase capacity.

III. Methodology

On December 21, 2015 the licensee requested a modification of the original license for an increase in capacity from 4 to 6 residents. An onsite inspection of the facility was completed on December 21, 2015.

IV. Description of Findings and Conclusions

The facility was originally licensed for 4 residents. The licensee divided the Northeast bedroom with a solid wall to create two resident bedrooms. The left side Northeast bedroom has the dimensions 13' x 16' and 208 square feet. The right side Northeast bedroom has the dimensions 12' x 16' and 192 square feet. Each room has an exit door and window. The right side Northeast bedroom does not have a closet and is furnished with two wardrobes for the residents' use.

V. Recommendation

I recommend that the capacity be increased from 4 to 6 residents.
