II. Purpose of Addendum

On 2/16/2016 Paraschiva Rusu submitted a verbal request to add a bedroom and living area to the current floor plan and to increase the capacity of her license from 3 to 5 residents. A written request was received on 3/10/2016.

III. Methodology

An on-site inspection was conducted on 2/16/2016. The additional bedroom and living area was measured to determine compliance with usable floor space requirements and the bathroom was observed.

IV. Description of Findings and Conclusions

Ms. Rusu added an addition onto the home that included an additional bedroom, living area and bathroom. The bedroom measurements were 10'9" X 12'1" which is 131.89 square feet. This is sufficient to accommodate two residents. The living area measured 21'5' X 12'10" (260.15 square feet). This, in addition to the other living area in the facility provides more than the required 35 square feet of living space for each resident. The bathroom was observed to provide adequate provisions for hand washing, bathing and toileting in accordance with rule requirements.

Ms. Rusu also provided a certificate of occupancy for the addition from the city of Dearborn Heights Building and Engineering Department dated 2/12/2015.

V. Recommendation

I recommend that the additional bedroom and living area be approved for resident use and the licensed capacity be increased from 3 to 5 residents.
