12/18/2015- Contact- Received documentation of Alzheimer's program statement and process of staff training.

12/18/2015-Inspection Completed On-site- inspected facility for safety mechanisms cited in program statement.

IV. Description of Findings and Conclusions:

On 12/18/2015, I reviewed the Alzheimer's Program Statement with licensee designee Theresa Alvarado and determined that it met the criteria outlined in Public Act 218. Further, Mrs. Alvarado has more than five years of experience caring for individuals with Alzheimer's and related dementia conditions as she previously ran a successful licensed AFC family home which provided care to aged individuals diagnosed with this condition. Mrs. Alvarado is also a registered nurse who specializes in geriatric nursing. I also reviewed the training tools used to educate direct care staff members about working with residents diagnosed with Alzheimer's/dementia conditions.

V. Recommendation:

Based on the information above, I recommend that the Alzheimer Program type be added.
