II. Purpose of Addendum

On 03/14/03, a vice president for Benchmark Homes of Saginaw # 5 Inc. requested a modification in the physical plant of Benchmark Homes of Saginaw Home # 5 Inc. Home # 4. Benchmark # 5 was requesting that the laundry room on the first floor of the home be converted to a small sitting room and the current sitting room be converted to a one-person bedroom. The laundry room would be moved to the basement. In addition, a second story bedroom that was currently licensed to house two residents would be converted to a one-person bedroom. The overall capacity of the home would not be changed and the facility would continue to be licensed for a maximum of 6 residents.

IV. Description of Findings and Conclusions

On 03/19/03, an on-site inspection was completed and measurements were taken of the current laundry room and sitting room. The laundry room was measured at 87.12 square feet. The current sitting room was measured at 115.8 square feet and has adequate space to house one resident as a bedroom.

V. Recommendation

It is recommended that the Licensee be allowed to convert the current sitting room to a one resident bedroom and the current laundry room into a small sitting room. It is further recommended that bedroom 2 on the second story be licensed to house only one resident.
