## II. Purpose of Addendum

To access and determine if Sasse Adult Foster Care Home can accommodate residents that regularly require wheelchairs and is equipped with an appropriate ramp at a primary means of egress from the first floor.

## III. Methodology

02/17/2016 Inspection Completed On-site

02/12/2016 Contact – Document received; letter dated 02/12/2016 from Salim and Susan Simwenyi requesting to change license type to receive wheelchair accessible residents.

## IV. Description of Findings and Conclusions

On 02/17/2016 I completed an on-site inspection. I observed that the bedroom located adjacent to the kitchen, listed as bedroom 3 in the original licensing study report, has 210 square feet and can accommodate two residents. In addition, the bedroom has an attached bathroom that provides appropriate toilet and showering facilities to address the needs of residents requiring regular use of wheelchairs.

A ramp was also installed off the 2<sup>nd</sup> means of egress, the patio door exit. The ramp was assessed and found to meet all requirements of the licensing rules for adult foster care family homes.

There are stairs located adjacent to the living room that leads to the basement. A gate has been placed at the top of the stairs to deny access to residents, those ambulatory and using wheelchairs, to ensure the safety of all residents.

## V. Recommendation

I recommend that Sasse Adult Foster Care Home adult foster care family home be deemed a wheelchair accessible facility.
