The new bedroom is located in the southwest corner of the facility. The room measures 9’6’ by 9’9’ with deductions for the wardrobe the room totals 90 square feet of living space. The resident’s bed will be moved from her current bedroom into the single room. As there is no change in capacity the living space and bathroom areas remain unchanged.

Approval was received from the Bureau of Fire Services on 08/31/2016.

V. Recommendation
