## II. Purpose of Addendum

To modify the home's capacity from three (3) residents to four (4) residents.

## III. Methodology

On 03/27/2017, I conducted an on-site inspection at the home, and took measurements of the home's three Resident bedrooms, as well as the home's indoor living and dining room areas.

On 05/17/2017, an original family adult foster care license was issued to the applicants, with a resident capacity of three (3).

On 05/21/2017, I was contacted by licensee Esther Mulili, who informed me that the resident capacity of three (3) was in error, and the home was supposed to be issued a license with a resident capacity of four (4).

## IV. Description of Findings and Conclusions

Bedroom #	Room Dimensions	Total Square Footage	Total Resident Beds
1	12' x 8'	96	1
2	14' x 10'	140	2
3	3' x 5' 11' x 10'	125	1

The indoor living and dining areas measure a total of 258 square feet of living space. This exceeds the minimum of 35 square feet per occupant.

## V. Recommendation

Based on the above information, this home can accommodate four (4) residents. It is the licensees' responsibility not to exceed the facility's licensed capacity.

I am recommending that the home's capacity be modified from three (3) residents to four (4) residents.
