## II. Purpose of Addendum

The purpose of this addendum is to determine if the Northwest bedroom of this facility is suitable to accommodate one resident. It is currently the licensee's bedroom and is not licensed but she wants the flexibility to change bedrooms with one of the residents if her bedroom would be more accommodating. The licensee understands that if this request is approved, she is not to exceed her licensed capacity of five residents at any time.

## IV. Description of Findings and Conclusions

On 06/28/18, I conducted an onsite inspection of this facility. I measured the Northwest bedroom and found it to measure 12'4" x 12'7" which is 168 sq. feet of usable floor space. In addition, the bedroom meets all of the licensing requirements to accommodate one resident.

## V. Recommendation

I recommend that the Northwest bedroom of this facility be licensed to accommodate one resident. The licensee understands that at no time is she to go over her licensed capacity of five residents.
