II. Purpose of Addendum

The purpose of this addendum is to define Angelica's Place home for the aged (HFA) ownership interest, the recent sale of the property the facility is located, and an executed lease agreement between the new landlord and licensee.

III. Methodology

On 5/1/18, an email was received from Joseph Ejbeh, shareholder and attorney for Romeo Property Holdings, LLC, reporting a change in ownership of the property the facility is located. He stated this change was effective 4/30/18. On 5/2/18, an email was received from Mr. Ejbeh containing a lease agreement. On 5/17/18, an email was received from Dr. Tatjana Savich (licensee shareholder) containing an updated BCAL 1600 application.

IV. Description of Findings and Conclusions

On 5/1/18, documentation was received updating ownership interest of the licensee effective 4/30/18. Angelica's Place of Romeo, Inc. ownership consists of Tatjana Savich (35% shareholder), Aleksander Savich (25% shareholder), Tracy Stuart (20% shareholder) and Joseph Ejbeh (20% shareholder). The landlord of the facility, Romeo Property Holdings, LLC, consists of the same individual owners and percentages of ownership as Angelica's Place of Romeo, Inc. I reviewed the lease agreement between Romeo Property Holdings, LLC (landlord) and Angelica's Place of Romeo, Inc. (Licensee) and found Angelica's Place has a legal right to occupy 328 E. Lafayette.

V. Recommendation


I recommend the status of the license remain unchanged.
