## II. Purpose of Addendum

This facility was originally licensed on 6/10/16 with a capacity of three (3) residents. Karen Britton, licensee, submitted a written request to increase the capacity of this facility to five (5) residents on 7/10/18. Ms. Britton stated that a bedroom previously used by a household member is now vacant due to the household member moving out of this facility. Ms. Britton stated that she will place two residents in this bedroom and she submitted a floor plan of the bedroom.

## III. Methodology

07/10/2018- Document received.

Received written request and floor plan from Ms. Britton.

07/25/2018- Inspection completed on-site.

## IV. Description of Findings and Conclusions

An on-site inspection of this facility was conducted on 7/25/18. The bedroom that Ms. Britton requested be licensed for two (2) residents is located on the first floor of this home. The bedroom measures 18'X16' for a total of 288 sq. ft. This is enough floor space for two (2) residents. The bedroom also contained all of the furniture required for the additional two (2) residents.

## V. Recommendation

I recommend that the capacity of this facility be increased to five (5) residents.




