#### II. Purpose of Addendum

The purpose of this addendum is to document a decrease in licensed bed capacity to accommodate the newly renovated memory care units on the first, second, and third floor "A" wing and the third floor "C" wing at the facility. Five resident rooms, including the kitchen, on each floor were replaced with new dining and living room space. 28 existing resident rooms were demolished to provide needed space for the renovations. The facility requested to decrease their licensed bed capacity by 32. The facility requested to be licensed for 236 beds.

#### III. Methodology

On 10/15/18, I completed an onsite inspection at the facility, specifically observing the renovation of the first, second, and third floor "A" wing and the third floor "C" wing.

On 10/15/18, Health Facilities Engineering completed their opening survey report. The report read the building was approved for resident Occupancy. Bureau of Fire Services granted full fire safety approval on 10/10/18.

## IV. Description of Findings and Conclusions

Holland Home Raybrook Manor is a three story building. The renovated first, second, and third floor make up the facility's "A" wing memory care units. The renovated third floor in the "C" wing is also a secure memory care unit.

The newly renovated first floor of the "A" wing is comprised of 11 single occupancy rooms and one double occupancy "suite" style room.

The newly renovated second floor of the "A" wing is comprised of 11 single occupancy rooms and one double occupancy "suite" style room.

The newly renovated third floor of the "A" wing is comprised of 11 single occupancy rooms and one double occupancy "suite" style room.

The newly renovated third floor of the "C" wing is comprised of 11 single occupancy rooms and one double occupancy "suite" style room.

The newly renovated first, second, and third floor "A" wing and the third floor "C" wing each have a living room, dining room, satellite kitchen, kitchenette, pantry area, medication preparation room, spa room, soiled/trash room, and storage areas. Every resident room is equipped with pull cords in the bathroom and living area, a TV, and a thermostat. The bathrooms in resident rooms are equipped with a toilet and a sink.

There are keypads at the entrance of each unit that require a code for entry. Each entrance also has a camera and doorbell so staff can see who requests entry into the units. Staff receive notification on the phones they carry during their shift when

the doorbell is pushed. There are also devices in the kitchenette areas of the units where staff can see who is at the door and allow them entry.

There is a newly renovated "green thumb room" on the first floor where residents can participate in gardening activities and pot plants.

Residents and family have access to a newly renovated laundry room on the third floor. The laundry room has six washers and six dryers available for use.

#### V. Recommendation

I recommend the facility's licensed capacity be reduced to 236.
