## II. Purpose of Addendum

The facility modified the facility to add a bedroom to the first floor of the home. The home was originally licensed with 3 bedrooms on the main floor and 3 bedrooms on the ground floor.

## III. Methodology

On July 2, 2018, I received an email from Joe Corak indicating that he would like to convert the private dining area into a bedroom on the main floor. I let him know that would be fine as long as the square footage meets the minimal requirements.

On July 31, 2018, I made an on-site visit to the facility and inspected the new bedroom.

## IV. Description of Findings and Conclusions

Bedroom 4 is now located on the main floor of the home it is 10'3" X 13'7" or 141 Sq. feet.

Bedroom 5 on the ground floor is identified as 10'6" X14'6" or 154 Sq. feet, this bedroom was identified as bedroom #6 in the original licensing report.

Bedroom 6 is on the ground floor and is 15'9" X13'7" or 208 Sq. feet, this bedroom was identified as bedroom #4 in the original licensing report.

The home now has 4 bedrooms on the main floor and 2 bedrooms on the ground floor. The capacity for this home has not changed. They continue to be licensed for 6 residents.

## V. Recommendation

I recommend no change to the status of this license.
