02/25/2019 – Searched department of Licensing and Regulatory Affairs (LARA) business entity search for Addington Place of DeWitt and located the business entity Addington Place of DeWitt.

02/25/2019 – Reviewed Bureau Information Tracking System (BITS) and determined the licensee and tax identification number have not changed, based on Ms. Stoinski's written request.

## **IV. Description of Findings and Conclusions**

By reviewing the licensee designee's written request to change the name of the facility, the LARA business entity search, and BITS I determined that the written request is for a name change only and there is no change in licensee nor tax identification number and a new license is not required.

**V. Recommendation**
