03/30/2019	On 03/20/2019, I conducted a renewal inspection at the facility.


## IV. Description of Findings and Conclusions

On 03/08/2019, I spoke with Debra Field via phone. She requested that the language in her OLSR "all staff shall be awake during sleep hours" be modified, as she does not currently have any residents in her home that require awake staff.

On 03/20/2019, I conducted a renewal inspection at the facility. and reviewed the assessment plans and health care appraisals for each resident. There did not appear to be any residents in care at the time who's needs required awake staff.

## V. Recommendation

I recommend the language in the OLSR be modified to ""The licensee will provide sufficient staffing for the home based on the current needs of the residents."
