II. Purpose of Addendum

The purpose of the addendum is to decrease the capacity from six to five residents and to change the southeast licensed bedroom to an office.

III. Methodology

On 07/02/2018, I received a written request from Larry Maniaci requesting a change in capacity for a decrease from six to five residents. The requested capacity is five adult male residents.

On 11/02/2018 I conducted an onsite renewal inspection. It was determined that the southeast bedroom will be converted to an office.

IV. Description of Findings and Conclusions

An onsite inspection was completed on 11/02/2018 and I determined that the capacity change is consistent with the change of bedrooms.

The bedrooms are as follows:

V. Recommendation

It is recommended that the capacity is decreased to five residents. It is also recommended that the southeast bedroom is converted to an office.


