### II. Purpose of Addendum

Addition of three bedrooms and increase the capacity to 6 residents.

### III. Methodology

On July 1, 2019 the licensee requested a modification of the original license for the addition of three bedrooms and to increase the capacity of the facility from 4 to 6 residents. An onsite inspection of the facility was completed on July 30, 2019.

## IV. Description of Findings and Conclusions

The facility was originally licensed for 4 residents. The addition is located on the east end of the facility. The addition consists of three resident bedrooms, a living room, dining room, and a full bathroom. Each resident bedroom has at least one window and a closet. The bathroom has a sink, toilet and a wheelchair accessible shower. Bedroom #1, Bedroom #2, and Bedroom #3 in the addition have the dimensions 11' x 15' and 165 square feet. The living room in the addition has the dimensions 20' x 15' and the dining room in the addition has the dimensions 20' x 11'. Each room has an exit door and window. The addition has an emergency exit that is equipped with a wheelchair accessible ramp.

#### V. Recommendation

I recommend the original license be amended and the facility capacity be increased to 6 residents.
