## **II. Purpose of Addendum**

The facility has requested to de-license 33 double occupancy rooms into single occupancy room consisting of 33 licensed beds.

## **III. Methodology**

On 11/4/19, licensing was notified by the authorized representative Hamza Sikander that de-licensing 33 beds was requested. Mr. Sikander provided updated room sheets for the facility. Resident rooms number 106, 108, 109, 111, 213, 217, 219, 300, 302, 303, 304, 305, 306, and 308 were reduced to one licensed bed each.

## **IV. Description of Findings and Conclusions**

On 11/6/19, I reviewed the room sheets for the facility. The rooms that are to be licensed for one bed was originally licensed for two beds. I find no conflicts with de-licensing 33 double occupancy rooms into single occupancy.

## **V. Recommendation**

I recommend the license capacity to be lowered to 93.


