#### III. DESCRIPTION OF FINDINGS & CONCLUSIONS

#### A. Physical Description of Facility

American House Rochester Hills is a one story, 50 bed home for the aged that caters to individuals aged 55 and older with memory impairments. It is a secured facility that requires access through a key code. Visitors may gain entrance by ringing a doorbell in the front vestibule of the facility.

The facility is comprised of two wings (east and west) that are conjoined by a corridor that houses various staff workspaces, laundry room and the commercial kitchen. The east and west wings are mirror images of each other and each contain 20 resident suites. The only difference between the two wings is the west wing houses the facility beauty salon. Each wing has activity space, resident laundry areas, a warming kitchen, dining room, two living rooms and an enclosed courtyard and patio.

The east wing consists of suites 1-20 and the west wing consists of suites 21-40. The facility offers both private and shared suites with double occupancy approved in suites 6, 9, 12, 18, 19, 22, 23, 32, 35 and 38. All resident suites are outfitted with a small kitchenette containing a sink and cabinetry for storage. All resident apartments contain a bathroom that has a sink, toilet and walk in shower. For safety reasons, all windows have limiters on then which restrict them from opening more than four inches.

Residents have the option to bring in their own furniture if they desire, so long as it meets fire safety requirements. If residents do not bring their own furniture, the facility will provide a twin bed, nightstand and wardrobe space. Each resident suite is outfitted with a call system that summon staff for assistance by means of pull cords located in each bathroom. When activated, the pull cords provide an alert notification to staff pagers that are carried on their person.

The facility has an emergency generator that is compliant with MCL 333.21335. Essential services are maintained during power outages such as heating and cooling, kitchen equipment and the fire detection system. Each resident suite contains designated outlets that are operated by the generator if power is interrupted.

The facility is outfitted with approved fire suppression systems throughout the building. On 4/30/2019 the Bureau of Fire Services granted an acceptable fire safety certification.

AH Rochester MC Subtenant LLC is the licensee of American House Rochester Hills. They have a management agreement between the licensee and American House Management Company LLC. A review of the Department of Licensing and Regulatory Affairs *Corporations Online Filing System* revealed AH Rochester MC Subtenant LLC is a Foreign Limited Liability Company with a Michigan qualification date of 11/9/2018.

## **B.** Program Description

American House Rochester Hills offers room, board and supervised personal care services to a total capacity of 50 individuals 55 years of age or older with a dementia or Alzheimer's diagnosis. The facility allows residents to choose their own primary health physician, specialist, licensed health care agency and/or hospice. The facility allows residents to choose their own personal pharmacy, Veteran Affairs if eligible, and/or the facility's contracted pharmacy, OneCare. Resident needs are assessed and an initial service plan is written prior to admission to the facility.

Staff training includes assistance in personal care, medication administration, disaster planning procedures, resident rights, behavior management and all services identified in residents' service plans.

The facility does not permit smoking, pets or bedrails and does not intend to hold any resident funds.

Beaumont Troy and Ascension Providence Rochester hospitals along with banking, pharmacy, retail and food establishments are located within a few minutes driving distance of the facility.

### C. Rule/Statutory Violations

The facility is in substantial compliance with home for the aged public health code and administrative rules.

## IV. RECOMMENDATION

I recommend issuance of a temporary license to this home for the aged that will allow it to operate for a period of six months with a licensed bed capacity of 50.
