On 02/12/2020, I informed Ms. Cooley via email the population age served for the facility is age 60-99.


On 02/12/2020, Ms. Cooley responded via email asking if they could get a waiver for the age requirement.

On 02/13/2020, I informed Ms. Cooley via email that the licensee designee can submit a signed letter requesting the population age change.

On 02/18/2020, I received a signed letter via email from licensee designee Rachel Bartlett, requesting modification of age to the license to accept people who are 50 years of age and older.

V. Recommendation

I recommend that the minimum age for the population served is modified from 60 to 50 years of age.
