II. Purpose of Addendum

IV. Description of Findings and Conclusions

The additional resident bedrooms include:

1 located in the north east of the home is 11'x12' or 132 square feet that can be used for double occupancy.

The second bedroom is also located on the east side of the home is 9.5'x11 or 104 square feet which is single occupancy.

I recommend an increase in capacity from 3 to 6 residents.
