Ms. Chinavare reported that there is a change in controlling interest and that the federal tax identification numbers will not change, therefore not requiring issuance of a new license. Ms. Chinavare submitted all of the trainings, verification of education, experience, and other related documents on 12/07/20 for consultant review and approval.

I received the final board meeting minutes on 12/10/20 confirming the sale of the business and appointment of Mrs. Voggu as licensee designee and administrator.

I reviewed and approved all of the required documents and determined that Mrs. Voggu meets the qualifications to serve as licensee designee and administrator for the Aged, Alzheimer's, and Physically Handicapped populations.
